I am a Registered Social Worker, Psychotherapist, and Member of the Ontario Association of Social Work (OASW), Ontario College of Social Workers (OCSWSSW) and Canadian Association of Social Workers (CASW). My practice is supervised by Rob Peach by way of Sex Therapy Toronto (STT). Mr. Peach is a Clinical Member of the Association for the Treatment of Sexual Abusers (ATSA), Associate Member for the Board of Examiners in Sex Therapy and Counselling of Ontario (BESTCO), and a Professional Member of the American Association of Sexuality Educators, Counsellors and Therapists (AASECT). STT focuses on providing assessment and treatment to men who have had difficulties with the law as a result of their sexual behaviours.

I have been seeing your client, Mr. John Doe, at his request to provide him with individual treatment as a result of his current matter before the courts. Specifically, I have seen him for four accelerated deep dive therapy sessions, on Aug 2, 15, 27, and 28 of 2019. Please know that one accelerated session is equal to two average short sessions. We have focused on developing and maintaining appropriate interpersonal boundaries in the context of intimate and sexual relationships. This includes in-depth sessions centering around an initial intake (bio-psycho- social wholistic assessment), before sex psychoeducation, legalities, responsibility, consent, boundaries, empathy, future management, and risk of re-offence.

A review of Mr. Doe's psychosocial and sexual history is unremarkable. He presents without any previous conflict with the law. He reports no previous difficulties in his life as a result of his sexual behaviours. He does not report any anomalous sexual interests, or impulsive behaviour patterns, specifically denying any coercive sexual preferences.

This paragraph will discuss the specific circumstances of the case, mainly the client's acceptance/non-acceptance of moral responsibility and plan of action. Direct quotations from sessions, grounded in authenticity, will also be included.

It is this writer's impression that Mr. Doe requires no further sex offence specific treatment at this time. However, I am willing to continue working with the client if he self-
